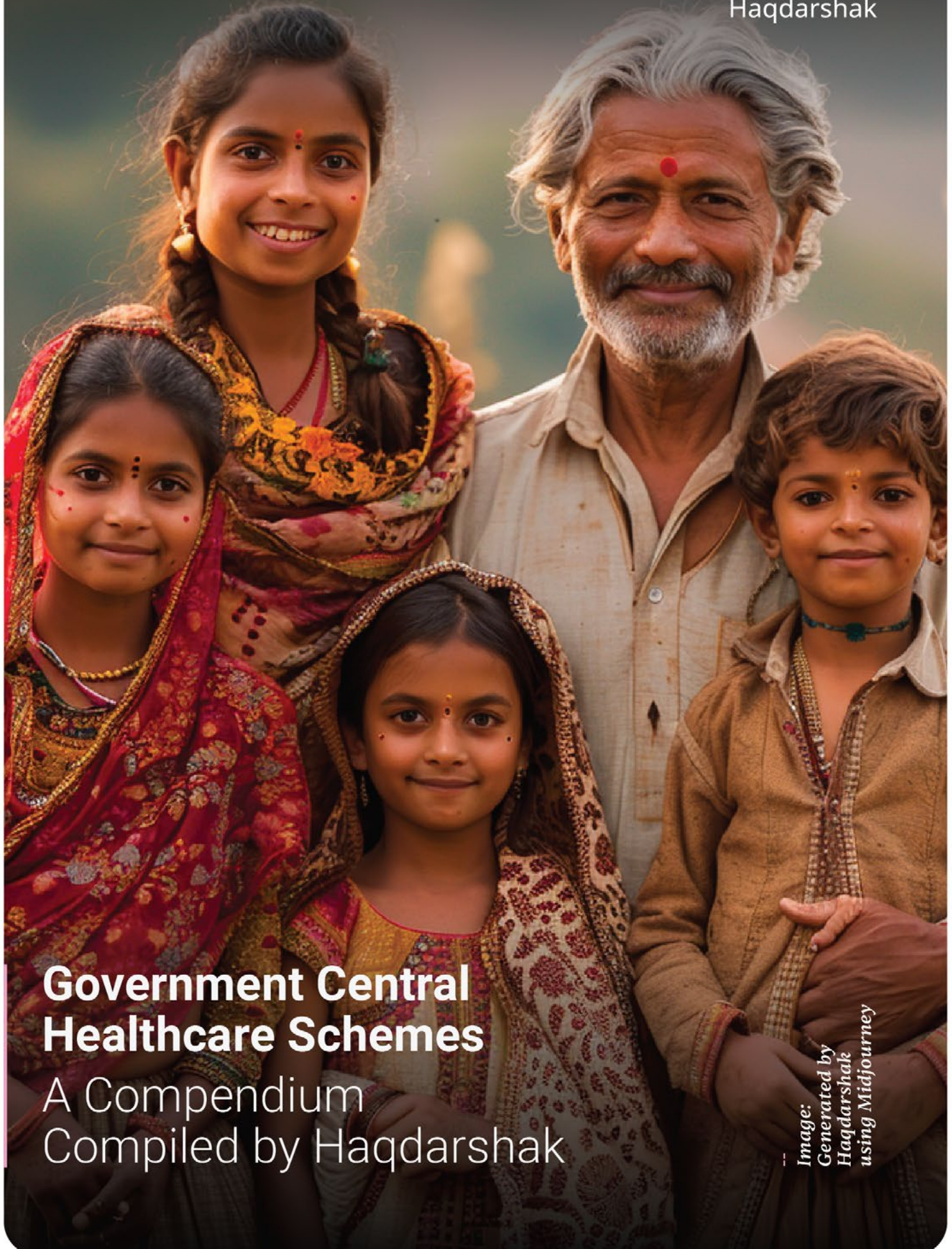

### 01/ Overview

#### 01.1/ About

The Ayushman Bharat Pradhan Mantri Jan Arogya Yojana (AB-PMJAY) scheme aims to provide financial protection and healthcare to economically weaker sections of society and other vulnerable groups.

It provides health insurance coverage of up to INR 5,00,000 per family per year for secondary and tertiary care hospitalisation.

#### 01.2/ Type

#### 01.3/ States Covered

### 02/ Benefits

- Health insurance coverage of up to INR 5,00,000 per family per year for secondary and tertiary care hospitalisation.
- It covers up to 3 days of pre-hospitalisation and 15 days of post-hospitalisation expenses, such as diagnostics and medicines.

### 03/ Eligibility

For rural areas, AB-PMJAY covers families who fall into at least one of the following six deprivation criteria (D1 to D5 and D7) and automatic inclusion criteria (are destitute / living on alms, manual scavenger households, primitive tribal group, legally released bonded labour) —

- D1 - Only one room with kucha walls and kucha roof
- D2 - No adult member between the ages 16 to 59
- D3 - Households with no adult male member between the ages 16 to 59
- D4 - Disabled member and no able-bodied adult member
- D5 - Scheduled Caste/Scheduled Tribe households
- D7 - Landless households deriving a major part of their income from manual casual labour

For urban areas, those belonging to the following 11 occupational categories of workers are eligible—

- Ragpicker
- Beggar
- Domestic Worker
- Street Vendor, Cobbler, Hawker, or other service provider working on streets
- Construction Worker, Plumber, Mason, Labour, Painter, Welder, Security Guard, Coolie, and other head-load worker
- Sweeper, Sanitation Worker, Mali
- Home-Based Worker, Artisan, Handicrafts Worker, Tailor
- Transport Worker, Driver, Conductor, Helper to Drivers and Conductors, Cart Puller, Rickshaw Puller
- Shop Worker, Assistant, or Peon in a small establishment, Helper, Delivery Assistant, Attendant, Waiter
- Electrician, Mechanic, Assembler, Repair Worker
- Washer-man, Chowkidar

Application Process**

**Offline**

- A family should approach their nearest Civil Hospital or Primary Health Care Center in urban areas or ASHA worker or Primary Health Care Center in rural areas to check if they are eligible for Ayushman Bharat Yojana, as per the SECC 2011 list.
- If the family's name is on the list, they can apply for an Ayushman Bharat Card with the required documents.
- The Card will be delivered to the applicant's address, with all the family members' names on the Card as per the family's Ration Card.
- The family can use this Card in empanelled hospitals to receive scheme benefits.

### 01/ Overview

#### 01.1/ About

This scheme provides health insurance coverage to Central Government employees and pensioners.

There are provisions to obtain life-saving drugs and consultations with specialist doctors at empanelled private hospitals in case of serious diseases, such as cancer, on referral from doctors at Health and Wellness Centres.

### 02/ Benefits

- Diagnosis, treatment, and reimbursements at scheme-prescribed rates.
- Medical investigations and cashless treatment at empanelled hospitals and diagnostic centres.
- Outpatient treatment, including expenses for medications.
- Note — no specific amount is mentioned.

### 03/ Eligibility

- All Central Government employees, who draw their salary from Central Civil Estimates, and their dependent family members residing in any CGHS-notified city.
- Central Government Pensioners or Family Pensioners who received a pension from central civil estimates and their eligible dependent family members.
- Sitting and Ex-Members of Parliament
- Ex-Governors & Lt. Governors
- Freedom Fighters
- Ex-Vice Presidents
- Sitting and Retired Judges of the Supreme Court
- Retired Judges of the High Courts
- Journalists accredited with PIB (in Delhi)
- Employees and pensioners of certain autonomous or statutory bodies that have been extended CGHS facilities in Delhi
- Delhi Police Personnel (in Delhi only)
- Railway Board Employees
- Post and Telegraph Department Employees
- Military Officers
- IAS officers on North-East and J&K cadres
- Employees of Kendriya Vidyalays Sangathan
- Note — dependents eligible for medical benefits include parents, parents-in-law (for female employees), unmarried son till the age of 25, unmarried/divorced/separated daughters, and minor siblings with an income less than INR 9,000 + daily allowance per month.

Application Process**

**Serving Employees**

- Submit the Application Form in the prescribed format, enclosing photos of eligible family members, to the Ministry, Department, or Office, where they are employed.
- The Application Form shall be forwarded by the Ministry, Office, or Department to the Office of the Additional Director, Central Government Health Scheme (CGHS) of the city for preparation of the CGHS Card.
- The Plastic Cards are distributed through the Wellness Centres for Pensioners. An SMS is also sent to serving employees. Deductions shall be made from the salary of serving employees as a contribution towards CGHS.

**Pensioners**

- One can get a CGHS Card made from the Office of the Additional Director of the City.
- The Application Form can be downloaded from the CGHS Website. Forms are also available in the office of the Additional Director of the city (in the case of Delhi, in the Additional Director Headquarters).
- Pensioners must provide attested copies of their Pension Payment Order (PPO) or provision PPO, or the last pay certificate if the PPO is not available.

- After enrollment, beneficiaries will receive a photo ID plastic card with policy details and a unique beneficiary number. The Card is valid until the primary insured's retirement date.
- In case of the primary insured's death, the Card becomes invalid. Dependent family members need to apply for a fresh card when drawing a pension.
- If the employee transfers to another department or CGHS-covered area, the same Card continues, with necessary changes informed by the department to CGHS.
- Pensioners who want to avail of CGHS facilities can contribute either on a yearly basis or a one-time (ten years) contribution for whole-life validity.
- Note — There is a provision for taking due approval for cancer treatment from a non-empanelled private hospital at CGHS rates. For pensioner CGHS beneficiaries, permission for treatment from non-empanelled hospitals at CGHS-approved rates shall be considered by the Additional Director, CGHS. However, no credit facility will be available for such a treatment. Pensioners have to make an initial payment and seek reimbursement at approved rates later. For serving Central Government employees, such permission is considered by the concerned Department/Ministry.

**05/  
Claims**

- Cashless treatment is available at CGHS. This includes pre-operative investigations, two preoperative consultations, room charges, medications, and the cost of implants (if necessary), all based on the CGHS package rates.
- For treatments received at non-empanelled hospitals and diagnostic centres, reimbursement can be obtained. The beneficiary must submit a claim to the employee's respective department and the Chief Medical Officer (CMO) of the CGHS Wellness Centre within a maximum of 6 months from the date of discharge from the hospital. To process reimbursement claims, relevant documents and proofs, such as a copy of the policy certificate, discharge summary, medical bills and receipts, and ambulance usage bills, must be submitted. Upon receiving these documents, the Wellness Centre will verify the details and facilitate the reimbursement process.
- To check the status of a claim, the CGHS computer module provides assistance by using the assigned claim number, allowing beneficiaries to track the progress of their claim.
- Note — detailed referral and permission procedures that exist for this scheme should be clarified at Wellness Centres at the time of treatment.

### 01/ Overview

#### 01.1/ About

This scheme provides full medical care in the form of medical attendance, treatment, drugs and injections, specialist consultation, and hospitalisation to insured persons and members of their families (where the facility for specialist consultation and/or hospitalisation has been extended to the families).

The patients or beneficiaries of Employee State Insurance (ESI) suffering from Rare Diseases are referred for screening, diagnosis, and complete treatment to either premier institutes or empanelled hospitals.

#### 01.2/ Type

#### 01.3/ States Covered

Government Central      Pan-India

### 02/ Benefits

- Covers up to INR 10,00,000 for treatment costs per year per ESI patient.

#### For rare diseases —

- Group I and II Diseases — these diseases are usually one-time treatments and are convenient for ESI beneficiaries. The cost involved in the treatment is lower than Group III and is available on the CGHS rate list. For these diseases, the ESIC will provide complete treatment without any capping of expenditure of INR 10,00,000 per year per ESI patient.
- Group III Diseases — these diseases are usually chronic and require long-term treatment. The cost involved in the treatment is very high. For these diseases, the Employee State Insurance Scheme (ESIC) will provide treatment after a recommendation of the High-Cost Treatment Committee and approval of the Hon'ble Chairman, ESIC. The High-Cost Treatment Committee will consider the cost of treatment, the financial status of the patient, and the availability of treatment options.

### 03/ Eligibility

- All “employees” engaged on a monthly remuneration not exceeding INR 21,000 in a factory/establishment to which the Act applies.
- Persons employed for wages on any work connected with the administration of the factory or establishment or any part, department, or branch thereof or purchase of raw materials, or distribution or sale of the product of a factory or establishment are also covered.
- Mines, Railway Running Sheds, Naval, Military and Air Force Workshops, and specified seasonal factories are excluded.
- The scheme also provides full medical cover to the dependants of insured persons.
- The insured person and their family are eligible from the date of entry of the insured person into insurable employment.
- Retired persons and permanently disabled insured persons are also eligible on the payment of a premium of INR 10 per month or an annual premium of INR 120.

This scheme provides financial assistance to cancer patients living below the poverty line for their treatment at regional cancer centres, tertiary care cancer centres, and state cancer institutes.

#### 01.2/ Type

Government Central

#### 01.3/ States Covered

Pan-India

### 02/ Benefits

- Financial assistance from INR 2,00,000 (or INR 5,00,000 in emergency cases) up to a maximum limit of INR 15,00,000.
- INR 2,00,000 is directly disbursed by the Regional Cancer Centre, whereas cases that require more funding are referred to the Ministry of Health.

### 03/ Eligibility

- The Applicant should belong to the Below Poverty Line category
- The Applicant should be availing treatment at one of the prescribed Regional Cancer Centres

### 04/ Application Process

- Fill in the prescribed Application Form by entering all the details correctly.

### 01/ Overview

#### 01.1/ About

Under this scheme, financial assistance of up to a maximum of INR 1,25,000 is provided to poor, indigent patients to defray a part of the expenditure on hospitalisation or treatment in Government Hospitals for life-threatening diseases covered under Rashtriya Arogya Nidhi (RAN), in cases where free medical facilities are not available.

#### 01.2/ Type

Government Central

#### 01.3/ States Covered

Pan-India

### 02/ Benefits

The scheme provides financial assistance towards treatment in Government hospitals including super specialty Government hospitals and institutes. The amount of assistance depends on the cost of treatment —

- Financial Assistance of INR 75,000 if the estimated cost of treatment is up to INR 1,25,000.
- Financial Assistance of INR 1,00,000 if the estimated cost of treatment is between INR 1,25,000 and INR 1,75,000.
- Financial Assistance of INR 1,25,000 if the estimated cost of treatment is above INR 1,75,000.

The assistance is provided either as a lump sum or on a monthly basis, as per the treatment. Reimbursement of expenditure already incurred is not permissible.

### 03/ Eligibility

- The applicant must be hospitalised, or currently undergoing treatment, in a Government hospital (including super specialty Government hospitals or institutes).
- The total annual family income of the applicant must not exceed INR 1,25,000 per annum.

### 04/ Application Process

- The duly filled application needs to be submitted to either of the following — the Doctor, Head of Department, or Medical Superintendent of the Hospital
- The Application Form, in prescribed proforma duly signed by the treating doctor and countersigned by the Medical Superintendent of the Government hospital or institute, will then be sent to the Ministry for approval.

The application will be processed by the Grants Section of the Ministry of Health and Family Welfare and the sanctioned amount will be directly disbursed to the hospital.
