01 / Financial Assistance for the Treatment of Terminal Diseases, Building and Construction Workers

01/ Overview

01.1/About

This scheme provides assistance up to INR 1,00,000 to Building and Construction workers registered with the Haryana Building and Other Construction Workers (BOCW) Welfare Board for the indoor treatment of fatal diseases like cancer, tuberculosis, AIDS, among others, as per government rules.

01.2/ 01.3/

Type States Covered

Government State Haryana

02/ Benefits

The scheme provides financial assistance of up to INR 1,00,000 for indoor treatment in case of fatal diseases, like cancer, tuberculosis, and AIDS.

03/ Eligibility

- All building and construction workers who are registered with Haryana BOCW Welfare Board with a minimum of a 1 year membership.
- It is necessary for the registered worker to have regular membership of one year.

04/ Application Process

- Contact the BOCW directly for the application process at the below-mentioned address —

- Submit the form along with necessary documents.

- Visit the official website at https://hrylabour.gov.in/.
- On the homepage, go to the "E-Services" section and make registration using an Aadhaar card or Parivar Pehchan Patra Family ID. Create a username and password.
- Then make a login at the homepage of the official Labour Department website and fill the Haryana Labour Welfare Fund Assistance for Treatment or Terminal Diseases registration form.
- Upload documents. Fill out and upload the work slip document.

02 / Haryana Labour Chikitsa Sahayata Yojana

01/ Overview

01.1/About

This scheme provides support to registered workers who have met with an accident or suffers from an illness.

If this registered worker is admitted for treatment in a government hospital, or a government-approved private hospital, for 4 - 30 days, the worker is given wage compensation or financial assistance as per the minimum wage prevailing in the state.

01.2/ 01.3/

Type States Covered

Government State Haryana

02/ Benefits

Under this scheme, the worker can receive financial assistance in the form of minimum wages for all the days they have been admitted into the hospital.

03/ Eligibility

- All registered labourers must have a minimum 1 year of membership or subscription.
- In the Identity Certificate of the registered labourer, the date of application and subscription amount needs to be stated.
- This facility is not applicable for medical treatment of more than 1 month in a single year.
- The Applicant should be admitted in a government or government-aided hospital for treatment for a minimum of 4 days and a maximum of 30 days to avail the benefit of this scheme. For this, they must produce a Hospital Certificate or other form of proof.

04/ Application Process

- Applicants must register on the Portal https://saralharyana.gov.in/
- Once logged in, Applicants will be guided through the Application Process.

05/ Claims

- The Applicant can claim service benefits by applying online and submitting the relevant documents.
- The claim amount will be transferred to the respective bank account by the department.

03 / Haryana Urban Development Authority Policy on Free Treatment for the Poor at Private Hospitals

01/ Overview

01.1/ About

This scheme provides free treatment to poor Below Poverty Line (BPL) category patients in private hospitals in Haryana.

01.2/ 01.3/

Type States Covered

Government State Haryana

02/ Benefits

Outdoor Patients -

- The Hospital Administration of those Hospitals which have been allotted sites in HUDA Sectors or any Urban Estate of Haryana shall provide free services to 20% of the total outdoor patients being attended to by them on first come first serve basis to such patients.

Indoor Patients –

- The Hospital Administration shall reserve 10% of the beds for free-of- cost to the members of the weaker sections of the society.

Super Speciality Hospitals —

- Super Specialty Hospitals shall charge subsidised rates, i.e. 30% of the normal charges, for 20% of the functional beds, in addition to providing free OPD services to 20% of patients from weaker sections of society.
- On treatment costs of up to INR 5,00,000 is free.
- On treatment costs between INR 5,00,000 to INR 10,00,000, charges will be 10% of the normal charge.

On treatment costs above INR 10,00,000, charges will be 30% of the normal charge.

Emergency Cases —

- All hospitals will have to admit patients in the case of an emergency.

03/ Eligibility

- Applicants must belong to a 'weaker section of society' this is defined as a person having a BPL Card or having a monthly income not exceeding INR 5,000.
- Applicants must be domiciled in Haryana.

Patients must visit the Administration Desk or Counter at the hospital to receive details on the application process.

Claims are settled internally at the hospital. Claim documents have to be approved from following offices -

- Chief Minister, Haryana
- Health Minister, Haryana
- Civil Surgeon or Nodal Officer of the District
- District Red Cross Society after approval by the President-cum-Deputy Commissioner

- Once you are an in-patient individual, an assigned doctor and medical coordinator will guide you through the treatment plan

Haryana — 06 / Chief Minister Relief Fund

01/ Overview

01.1/ About

The Chief Minister Relief Fund (CMRF) is a corpus fund set up by the Government of Haryana to provide financial assistance to people affected by natural calamities, accidents, or other unforeseen circumstances.

The Fund is also used to provide medical assistance to people who cannot afford to pay for their treatment. 25 chronic diseases are covered for this assistance including cancer, acute myeloid leukaemia, Prader-Willi syndrome, nephrotic syndrome, and thalassemia. Diseases that are not covered under the Ayushman Bharat scheme may also be considered here.

Type States Covered

Chief Minister Relief Fund Haryana

02/ Benefits

25% of the treatment cost will be provided as financial assistance, up to a maximum amount of INR 1,00,000.

03/ Eligibility

Applicant must be a resident of Haryana

04/ Application Process

Online Process

- Applicants need to create an account and apply on Saral Portal with their Parivar Pehchan Patra ID, mobile number, and email ID. Create login ID and password https://saralharyana.gov.in/
- To complete this process applicants need to login, select a scheme, fill in their details, and upload their medical records and other related documents like their OPD bills.
- As soon as the applicant submits his application, the application will be sent to the MP, MLA, President, Zila Parishad President, Block Committee Mayor, MC President of the concerned area. These people's representatives will send their cases to the Deputy Commissioner with their recommendations within 5 days. The DC will then send the details to the Tehsildar concerned and the medical documents to the Civil Surgeon for verification.
- The scheme amount will be sent to the beneficiary's bank account only after all the process is done.
- Applicants may track the application with the tracking ID on the SARAL portal or by SMS. Type SARAL and send to 9954699899 to track your application from your registered mobile number or Type SARAL<space><Application ID/Ticket No.> and send to 9954699899 to track your application/ticket.

Haryana — 06 / Chief Minister Relief Fund

Offline Process

Applications may be made to the district level committee. Medical records and OPD bills must be provided.

05/ Claims

- Medical assistance shall be transferred to the beneficiary's bank account.
- A review meeting of this scheme is organised every 15 days and applications received on the portal are processed promptly.
- As soon as a needy person up to a certain income applies on the portal, a message with their details will go to the public representative of the concerned constituency, the MLA.
- After receiving the applications, the Deputy Commissioner will make the final recommendation as officers.
- Information will be sent to Tehsildar for verification of income and land-property and to CMO office for verification of illness and expenditure on it.
- The verifications will have to be completed within a week, so that the patient or the person undergoing treatment can get the benefit of financial assistance on time.
