The benefit of the scheme will be given to the employees/pensioners of PSPCL and their dependents who will opt for the same.

04/ Application Process

Provide the empanelled hospital with a PSPCL Identity card and other documents at the time of using services to obtain the discount.

05/ Claims

- Payment of OPD and IPD will be made directly to the hospital by the employee/pensioner and their dependents.
- However the employee/pensioner/family pensioner' is entitled to get reimbursement, and can claim reimbursement from PSPCL as per prevailing instructions and at the rates/ amount verified by the Health Department wherever applicable.

03 / Punjab Government Employees and Pensioners Health Insurance Scheme

01/ Overview

01.1/ About

The Punjab Government Employees and Pensioners Health Insurance Scheme (PGEPHIS) is a comprehensive health insurance scheme launched by the Punjab Government for its employees and pensioners and their dependents. The scheme provides cashless and paperless treatment at empanelled hospitals across the state.

To be eligible for the PGEPHIS scheme, personnel must be in active service with the Punjab government or be a pensioner. Their dependents, including spouses, children, and parents, are also eligible for coverage.

- State Government Punjab Employee Scheme

02/ Benefits

This scheme provides hospitalisation expenses up to INR 3,00,000 per family per year.

In case, the sum insured of INR 3,00,000 per family is exhausted, the coverage of the family shall be met through the Buffer Sum Insured of INR 25,00,00,000 available to every beneficiary of the group, on a group floater basis, which is maintained by the Insurance Company.

03/ Eligibility

All personnel of the Punjab Government including All India Service Officers, Serving, Newly Recruited, Retired, and Retiring who are covered under the existing Punjab Medical Attendant Rules [CS(MA) Rules, 1940] shall be offered Health Insurance Scheme on compulsory or on an optional basis.

04/ Application Process

- Download and fill in the application form https://ppcb.punjab.gov.in/sites/default/files/documents/Cashless%20Scehme.pdf (from page 5)
- Submit the complete application form and necessary documents to the PEGSIC office or your HR department.
- Once your application is processed, you will be issued a PGEPHIS card. This card will contain your Unique Beneficiary Identification Number and the names of all family members covered under the scheme.

05/ Claims

- Get admitted to an empanelled hospital. When you are admitted to an empanelled hospital, inform the hospital staff that you are a PGEPHIS beneficiary.
- Submit your PGEPHIS Card. The hospital staff will verify your eligibility and submit your PGEPHIS Card to the Insurance Company.
- Get pre-authorization (if required). For certain medical procedures, pre-authorization is required from the insurance company.
- Undergo the treatment and get discharged. The hospital will then send your claim to the insurance company for processing.
- Once your claim is processed, you will receive your claim amount directly into your bank account.

04 / Mukh Mantri Punjab Cancer Raahat Kosh

01/ Overview

01.1/ **About**

This scheme provides financial assistance and support to cancer patients and ensures access to quality healthcare.

01.2/ 01.3/

Type States Covered

- Government State Punjab

02/ Benefits

This scheme provides financial assistance of up to INR 1,50,000.

03/ Eligibility

- The beneficiary should be a resident of Punjab.
- The patient must have a confirmed diagnosis of cancer from a recognized healthcare institution.

04/ Application Process

- The patient or the relative needs to fill in the application form at the hospital where treatment is sought.
- The hospital then shall register the patient.
- The Health and Family Welfare Department reviews and processes the application for approval.
- Once the application is approved, the sanction copy is sent back to the Civil Hospital where the patient initially submitted the form.
- A copy of the sanction is submitted to the Post Graduate Institute of Medical Education and Research (PGIMER) or the hospital referred to for the patient's treatment.
- The hospital receiving the patient's referral is informed about the sanction copy through the Grant Cell, ensuring the necessary arrangements for treatment.
- Application status can be tracked here —

05/ Claims

- Fill in the application with the required documents at the Civil Surgeon's office.
- The application undergoes a security check and is recommended by the Deputy Commissioner.
- It is then sent to the State Head Quarter for review.
- After a pre-facto sanction is issued, the patient then can receive cashless treatment at the empanelled hospital.

06/ Documents Required

- A report from a recognized healthcare institution confirming the diagnosis of cancer is mandatory. This report should provide details about the type and stage of cancer.
- Blood Group Confirmation: Along with the confirmation report, the blood group of the patient needs to be provided. This information is necessary for medical purposes and to ensure appropriate care during the treatment.
- Proof of Identity: Any of the following documents can be submitted as proof of identity:
- Voter Card
- Driving Licence
- Passport
- Arms Licence
- Kisan Credit Card with a Photograph
- Aadhar Card (optional)
- Photograph

06 / Scheme for Reimbursement of Expenditure Incurred for the Treatment of Serious Ailments of Beneficiary Construction Workers Engaged in Construction Work and their Dependents

01/ Overview

01.1/ **About**

Under this scheme, the Punjab Building and Other Construction Workers Welfare Board has approved the reimbursement rates of a maximum of INR 1,00,000 or the actual expenditure, whichever is a lower amount, for the treatment of cancer.

Type States Covered

- Government State Punjab

02/ Benefits

This scheme provides a maximum coverage of INR 1,00,000.

03/ Eligbility

- The Construction Workers must be registered as 'beneficiaries' with the Punjab Building and Other Construction Workers Welfare Board.
- If the financial assistance is to be taken for the treatment of the dependent, such dependents should be a member of the family of the Construction Workers and proof of their dependency shall be produced.

04/ Application Process

- The expenditure on treatment of the disease must be verified by the Civil Surgeon.
- Any beneficiary who intends to avail the benefit under this scheme will have to first exhaust the benefit of INR 50,000 for all his health ailments under the Bhagat Puran Singh Sehat Beema Yojana Scheme. Only then he can get the benefits for the remaining amount under this scheme.

05/ Claims

- Submit the required documents to the Punjab Health Systems Corporation (PHSC) Office. You will also need to submit the following —
- A copy of your Discharge Summary.
- A copy of your Hospital Bill.
- A copy of the Receipt for the amount that you have already paid to the hospital (if any).

07 / Employee State Insurance Scheme

01/ Overview

01.1/ About

This scheme provides complete medical care in the form of medical attendance, treatment, drugs and injections, specialist consultation, and hospitalisation to the insured persons and members of their families where the facility for Specialist consultation, hospitalisation has been extended to the families.

Beneficiaries of the Employee State Insurance Scheme (ESIC) suffering from Rare Diseases are referred for screening, diagnosis, and complete treatment either to premier institutes or empanelled hospitals.

Type

States Covered

- Employee State Insurance Scheme Punjab

02/ Benefits

This scheme covers up to INR 10,00,000 treatment cost per year per ESIC Patient.

03/ Eligibility

- All "employees" engaged on a monthly remuneration not exceeding INR 21,000 in a factory/ establishment to which the Act applies.
- Persons employed for wages with the administration of the factory or establishment or any part, department, or branch thereof or purchase of raw materials, or distribution or sale of the product of a factory or establishment are also covered.
- Mines, Railway Running Sheds, Naval, Military, and Air Force Workshops, and specified Seasonal Factories are excluded.
- The scheme also provides complete medical cover to the dependants of insured persons.
- The insured person and their families are eligible from the date of entry of I.P. into insurable employment.
- Retired persons and permanently disabled insured persons are also eligible for payment of a premium of INR 10 per month or an annual premium of INR 120.

- Family members shall obtain an Aadhaar-based Pehchan Card from the portal.
