01/ Overview

01.1/ About

Under this scheme, cashless medical treatment facilities are provided to government servants, retired government servants, and their dependent families in Uttar Pradesh.

To get the benefit of the scheme, every eligible beneficiary must have a State Health Card. Cashless treatment will be available in the empanelled hospitals after verifying the beneficiary's identity with the State Health Card.

01.3/ States Covered

Uttar Pradesh

02/ Benefits

This scheme provides cashless medical treatment of up to INR 5,00,000 per annum, if availed at a private empanelled hospital. There is no limit to the cashless treatment amount if the treatment is availed at a government medical institution or hospital.

03/ Eligibility

This scheme is open to government servants, retired government servants, and their dependent families of Uttar Pradesh.

04/ Application Process

- Enter Aadhar linked mobile number to login here – <https://sects.up.gov.in/public/starttoapply.aspx>
- Fill in the Form details and upload a passport size photo
- Submit the application

05/ Claims

The claim process will be initiated and detailed at the hospital itself.

- Passport Size Photo

- MLA Discretionary Fund
- Uttar Pradesh

Benefits**

The scheme provides a benefit of up to INR 10,00,000 per person, as per their need.

**03/
Eligibility**

- Resident of Uttar Pradesh.
- Any patient in need who cannot afford treatment, with a preference for families from a Below Poverty Line (BPL) category.
- Should be residing in the constituency of the MLA with whom the request has been made.
- Private hospitals can demand equipment for screening and treatment.

**04/
Application Process**

- Patients can contact the district office of MLA and submit their application.
- Alternatively, a hospital can also apply for application on a patient's behalf.
- The application format and processes are available at the MLA Office and the hospital admin department.

Claims**

All claims are settled internally at between the MLA LAD and the hospital.

01.1/ About

The Chief Minister’s Discretionary Fund provides financial assistance to needy individuals for the treatment of major ailments like cancer, cardiac surgery, kidney transplant, brain tumours, liver or multi-organ failure, at specified government or empanelled hospitals.

01.2/ Type

- State Government

01.3/ States Covered

Uttar Pradesh

02/ Benefits

This scheme provides a variable grant as per the Chief Minister’s discretion.

03/ Eligibility

- Resident of Uttar Pradesh
- Any patient in need who cannot afford treatment, with a preference for families from a Below Poverty Line (BPL) category.
- The Applicant must require treatment for a major ailment.
- Needy people injured in accidents, cancer, heart disease kidney transplants, and accident-related cases

04/ Application Process

- Obtain an Application Form from the Uttar Pradesh government website, the District Collector Office, or the concerned hospital.
- Fill in the form, attach the necessary documents, and submit it to the Chief Minister Discretionary Fund District Committee.
- Alternatively, contact the hospital where treatment is being taken.

05/ Claims

The applications will be considered by the District Committee and the Chief Minister’s office and funds will be transferred to the bank account of the beneficiary.

02/ Benefits

The scheme provides benefits for treatment costs up to INR 5,00,000 in a financial year

03/ Eligibility

- Resident of Uttar Pradesh
- The Applicant must be from an Economically Weaker Section (EWS) or Below Poverty Line (BPL) background.
- The Applicant must be a victim of disaster.

04/ Application Process

An offline application can be submitted at the hospital.

05/ Claims

The claim process will be initiated at the hospital.

01.1/ About

The Employee State Insurance Scheme (ESIC) provides medical facilities to the insured person and their families.

01.2/ Type

01.3/ States Covered

- Employee State Insurance Scheme
- Uttar Pradesh

02/ Benefits

Benefits differ for medical, disability, unemployment, funeral costs, sickness, rehabilitation, and old age care.

03/ Eligibility

The Applicant must be the Insured person, or a family member of the insured person.

04/ Application Process

- The bill will be submitted by the Empanelled Centre for payment to the Medical Superintendent concerned with necessary supporting documents immediately after completion of treatment in respect of Employee State Insurance (ESI) beneficiaries referred/permitted by the respective Medical Superintendents.
- The Medical Superintendents shall, however, ensure the release of payment within 3 working days after the submission of the bills by the tie-up hospitals. Three days include the processing of bills by Medical Superintendents and the release of payment by the Accounts Branch concerned.
- The Empanelled Centre shall directly charge the individuals for telephone charges and extra diet charges, so incurred by the patient or any of his family members during their stay in the Empanelled Centre.

05/ Claims

- Employees must show their ESIC ID card issued by their employer at the hospital.
- The hospital will then process the application for verification and approval.

- ESIC Card (issued by the employer)
- ID Card
- Aadhar Card
